

MOBILISESME. WHAT IS IT?

The **MobiliseSME** is the second pilot project of a Mobility Exchange programme for SME staff. The programme has several **Local Contact Points** in the EU (*Chambers* of *Commerce, Foundations, Innovation Agencies and Incubators*) that will help you to register in the matchmaking platform and to find a SME to collaborate with. MobiliseSME allows using the scheme to boost collaborations or projects taking place between two companies.

- It gives the chance to develop skills and capacities for SME staff;
- O It boosts new business ideas in different EU markets;
- O It strengthens SME's already existing partnerships.

WHY TO BE A SENDING COMPANY?

It is a ONCE-IN-A-LIFETIME opportunity. YOU and YOUR company will:

- O Widen your network of contacts at EU level;
- Be part of an experience that will provide new insights and ways of doing business in a different EU country;
- Gain knowledge of a specific technology, method or innovation you are interested in;
- O Develop intercultural and language skills in a business environment;
- Get access to international markets and the opportunity to establish new partnerships.

YOU CAN PARTICIPATE IF...

- You are considered a Small and medium-sized enterprise (UE definition of a SME). One-man enterprises and some liberal professions are allowed to participate. Larger companies cannot participate as SENDING COMPANY.
- Your SME is legally registered in an EU Member State; Iceland and Norway in accordance with the EEA Agreement; Albania; Republic of North Macedonia; Montenegro; Serbia and Turkey.
- You have a serious plan or intention to conduct **business abroad**.
- Employees, managers, owners and co-owners of the Sending Company may participate. Consult the Local Contact Points for further details.

MobiliseSME provides **practical and financial assistance** for Small and medium-sized enterprises (*SMEs*) and their staff (*employees, managers and owners or co-owners*) who stay for a short period of time with another SME (*Host Company*) in another EU country.

Staff remain employed by the Sending Company during the period of the secondment. So, the participant you are hosting is still employed by his/her company in his/her home country.

There are **no deadlines** or calls to participate. The MobiliseSME project works on an on-going basis. The temporary exchange may last a minimum of 1 month and a maximum of 6 months.

For the matching process and supporting services, diverse Local Contact Points are available for the arrangements in several European countries.
